

TERMS AND CONDITIONS OF THE PROMOTION

PROMOTION ORGANISER

The company Sociedad Deportiva Eibar SAD with registered address at Ipurua Kalea 2, 20600 Eibar, with TAX ID A20039533 is organising the following promotion:

SCOPE

PRIZE

- Complete the ARMERO FAN registration and pay the corresponding annual subscription.

The data of the participants provided through this form may be verified at any time by the organisers of the promotion, SD Eibar, to check the requirements set out in the terms and conditions of this promotion.

Publicity for the promotion will be carried out through the SD Eibar social networks.

SELECTION AND NOTIFICATION OF THE WINNER
